



## Pre-registration for Auction Attendance Remote Bid Service

- ✓ The telephone bidder number (one-day use) will be sent to your registered e-mail address after the completion of the pre-registration.

\*If you do not receive any email from us, please contact us at any time.

- ✓ **If you are a successful bidder with “Telephone Bid”, the Remote Service Fee will be charged on top of the machine cost.**

\*Due to the severe situation of the Covid-19, the Remote Service Fee is 10,000 JPY for each unit only for this time although it will be charged normally 1 % of machine cost (Min. 10,000 JPY – Max. 100,000 JPY).
